## Background

- A. On 10 May 2012 the Waikato Regional Council (the Council) and the Raukawa Settlement Trust (the Trust) signed a Joint Management Agreement (Agreement).
- B. Of importance and paramount to the ongoing positive relationship is the effective engagement and management of the Environment Court appeals including case management of the appeals. To assist with this the Parties have agreed on a process to manage the Environment Court appeals under Schedule Two.
- C. The Parties have also agreed to vary aspects of the engagement protocol for the resource consent processes under Schedule Three.
- D. The Agreement is now being varied to provide for the abovementioned provisions.

## Matters agreed

- 1. This Addendum is effective from **10 October 2014**.
- 2. The Parties agree that the Agreement can be varied as follows:
  - 2.1 The addition of a new clause under Schedule Two.

### **Clause 4.8 Environment Court –**

The Trust indicated to the Council that they wish to have a more active engagement approach through the Environment Court Appeals period. To provide for this the following process has been agreed between the Parties.

#### Agreed process:

- (a) Prior to lodgement of an appeal under schedule 1 clause 14 of the RMA to an RMA planning document (as it relates to the Vision and Strategy), Raukawa will notify the Council of its intention to file.
- (b) Where possible and prior to lodgement, the Parties will discuss content and rationale for the appeal.
- (c) Following lodgement of an appeal, the Parties will discuss:
  - (i) Case management of the Raukawa appeal; and

(ii) Process and expectations with regard to Raukawa involvement in appellant and RMA s 274 meetings and mediations.

(d) At all times, the Parties will act in good faith and in accordance with the relationship principles, pursuant to clause 4.2 of the Agreement.

2.2 The amendment to Table 1 – **Engagement Protocol** - Provision 1 under Schedule Three.

This clause will be replaced and amended as follows:

Within 1 (one) working day of receiving an application as complete under s 88 of the RMA or otherwise as soon as reasonably practicable, the Council will provide to the Trust a summary of resource consent applications received.

The summary shall include the following information (if relevant):

- Name of Consent Applicant(s);
- Consent applied for;
- Consent number;
- Brief description of each activity applied for;
- Type of activity;
- Location of property/activity; and
- Relevant Consent Officer contact details-

3. The remaining terms and conditions of the Agreement are confirmed in all respects except for the variation as set out in this Addendum.
